- 5) Agrees to immediately advise in writing the person in charge of the Franklin Pierce University event and/or The Marlin Fitzwater Center for Communication of any injury, illness, or loss that occurs to the Participant during the event;
- 6) This Consent and Acknowledgment of Risk shall not be amended, supplemented, or abrogated without the written consent of Franklin Pierce University in Rindge, New Hampshire;
